

The Role of Digital Ethics in Strengthening Character Education in the Digital Age

Abstract

The increasingly massive use of digital technology has influenced the process of life, one of which is in the field of education. Digital technology has been widely used in the learning process from the elementary to university levels. The use of technology also needs to be accompanied by strengthening character education, which can be done through understanding digital ethics. Digital ethics provides an understanding of moral standards and rules that can be carried out to utilize digital technology. Strengthening character education through digital ethics in the current era is necessary because the teaching and learning process uses more digital technology. The research method used is a literature study approach with descriptive analysis. This study aims to provide an understanding of the contribution of digital ethics applied in daily life to character education in the digital era. The results show that digital ethics has a role in efforts to strengthen character education in the digital era. This is shown through applying moral standards and rules that must be carried out in digital activities. So that applicable rules can direct all digital activities. Abstract

Penggunaan teknologi digital yang semakin masif memberikan pengaruh terhadap proses kehidupan salah satunya di bidang pendidikan. Teknologi digital telah banyak digunakan dalam proses pembelajaran dari tingkat dasar hingga perguruan tinggi. Penggunaan teknologi tersebut juga perlu diiringi dengan penguatan pendidikan karakter yang dapat dilakukan melalui pemahaman etika digital. Etika digital memberikan pemahaman terkait dengan standar moral dan aturan yang dapat dilakukan dalam upaya pemanfaatan teknologi digital. Among the positive impacts caused by the development of technology and information is easier access to information without space and time constraints. However, the presence of technological development is also slowly changing the order of human life, and some jobs are being replaced by technology. Based on data obtained by the *World Economic Forum* (WEF), 69 million new jobs will be created, and around 83 million old jobs will be lost. (Hendrarto, 2023). Jobs that will be much needed in the future are digital-based jobs, so they can be done from various places without space and time restrictions. Responding to the challenges that will occur in the future, it is necessary to strengthen and prepare the abilities of future generations. One of them is through strengthening digital character. This is an important reason because in doing work in the future, there will be more interaction in the digital space than in the real world.

2. Literature Review

2.1 Digital Ethics

Digital ethics is a competency that individuals need to be aware of, consider, and develop in using the Internet in everyday life in order to utilize it wisely. In addition, when using the Internet, students are also required to reflect on their behavior and manners when using digital technology and be able to practice digital ethics. (Syah *et al.*, 2023). Digital ethics has interpersonal, social, organizational and national norms that regulate how digital users can behave in accordance with the rules that apply in the digital world. Digital ethics is a digital transformation paradigm that is immune to moral bias from humans, so humans are expected not to allow digital machines to discriminate against ethical values that apply to society. Not only that, digital ethics also works in two directions, namely, from humans to machines and from machines to humans. (Deloitte, 2022). Digital ethics is also understood as the ability of individuals to model and consider digital ethical governance in everyday life. (Guntar, Ardiani & Fitriani, 2023).. In today's all-digital conditions, not a few deviations from digital ethics lead to crimes such as *bullying*, fraud, spreading hoax content, and others. Digital ethics has several problems related to trust, honesty, and moral values. (Sari, Rejekiningsih & Muchtarom, 2020).. In the current situation, the younger generation, especially social media users, is faced with several attitude choices due to changes in the times, such as consumerism, individualism, radicalism and others. These attitudes can be found in internet users who currently deviate from social values and norms.

Young people dominate users of digital technology in Indonesia. Based on research conducted by Microsoft related to the level of politeness of Indonesians, netizens ranked the least polite in Southeast Asia, with 76, which indicates a low level of politeness. (Nugraha, 2023). Thus, these situations and conditions require strengthening digital ethics because they relate to manners and regulations regarding the use of digital technology, especially social media. Digital ethics covers how netizens interact directly and relates to how to disseminate and respond to content found on social media platforms. To maintain digital integrity and ethics, users of social media platforms need to recognize the impact of violating digital ethics. This requires a culture of building a digital ethics ecosystem that can be understood and applied in everyday life.

2.2 Character Education

Character education plays an important role in realizing the nation's next generation. There needs to be collaboration from various parties, including parents, teachers and the surrounding environment, to shape character. Character education is more focused on a person's actions or behavior, such as if someone behaves badly, dishonestly or cruelly, then that person is manifested as bad behavior. This research is a qualitative study with a library research design in which the data collection model is done through digital searches. Regarding the time parameter of publication, the data was collected from the 2019-2023 timeframe. More specifically, the author collected data

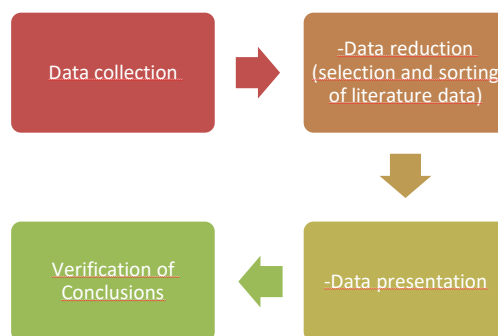


Figure 1: Research flow

initiative supports the learning process that emphasizes academic integrity. So, this case is also relevant to the application of digital ethics in the learning process.

In line with the above, digital ethics is the cornerstone of efforts to build a proactive and aggressive character education program tailored to the digital youth. Digital ethics must be understood by all parties, such as teachers who are tasked with disseminating knowledge and fostering an online and safe environment for students. Not only that, digital ethics also includes and ensures inclusivity and diversity in online learning. An educator must also curate diverse learning content and foster a sense of solidarity among students. Emphasizing inclusivity in the school environment contributes to strengthening the understanding of equitable character education through the application of digital ethics. Digital ethics not only focuses on the use of social media but also provides direction on the attitudes that must be shown on social media. This will reflect one's character. As the digital world continues to evolve, it is necessary to uphold ethical standards for a better future of character education. By implementing digital ethics, educators can ensure inclusive, respectful and equal learning. This is demonstrated through online learning. 5. Conclusion

Based on the results of the above research, it can be concluded that the role of digital ethics in strengthening character education in the digital era is that digital ethics provides a foundation and direction in efforts to use digital technology. This is done in response to the rampant deviation of character in the use of digital technology, such as the many cases of bullying, spreading hoaxes, plagiarism, and other crimes.
